1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property comprises a two storey, detached dwellinghouse.
Accommodation	The accommodation can be summarised as follows:
	Ground Floor - Entrance Vestibule, Living Room/Dining Area, Kitchen, Side Hallway with Utility Room and WC off.
	First Floor - Landing, 3 Bedrooms (One with En-Suite Shower Room), Bathroom
Gross Internal Floor Area (m²)	103m2 or therby.
Neighbourhood and Location	The subjects are situated within a modern private residential cul de sac within the Westercraigs development on the southern side of Inverness. Immediate surrounding properties comprise dwellings of a generally similar age and type, together with an open area of woodland to the rear. All main facilities and amenities may be found within relatively close proximity.
Age (Year Built)	Circa 2009.

Weather	Dry.
Chimney Stacks	Not applicable.
Roofing including Roof Space	The roof is of pitched design, clad with concrete tiles and incorporating a tiled ridge.
	There was access gained to the accessible roof void area via a ceiling hatch and fixed ladder within the first floor Landing. The loft area has been partly floored whilst fibreglass insulation has been laid between the ceiling joists.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
Rainwater Fittings	The gutters and downpipes are of plastic manufacture.

	Visually inspected with the aid of binoculars where appropriate.
Main Walls	The main outer walls are of modern cavity construction comprising a structural timber frame inner leaf and roughcasted concrete block outer leaf, together with some facing synthetic block features.
	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, External Doors and Joinery Windows comprise uPVC, double glazed units. The front entrance door is of timber construction whilst there are uPVC, double glazed French doors at the rear. The external roofline fascia boards are formed in uPVC. Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open.

	Within the rear garden, there is a Summer House/outdoor office. The outer walls are of timber frame and timber clad type under a profile metal clad roof.
	Additional outbuildings also comprise a timber and profile metal shed to the side of the dwellinghouse.
	Visually inspected.

Outside Areas and Boundaries	There are areas of private garden ground lying to both the front and rear.
	The rear garden is laid with grass and paving, whilst boundaries are formed in timber board fencing.
	There is a paved surfaced driveway/off street car parking area to the front.
	Visually inspected.

	Using a moisture meter, walls were randomly tested for dampness where considered appropriate.	

Floors Including Sub-Floors	The flooring at ground floor level is of solid type, whilst the first floor is of suspended timber construction. We would, however, emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings. Given the nature of construction, there was no access gained to any subfloor areas.
	Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Internal Joinery and Kitchen Fittings	The internal skirtings and architraves are of painted timber finish, whilst internal doors are of modern timber type. The Kitchen units have been upgraded in the past and comprise a modern range of wall mounted cabinets and worktop surfaces with integrated appliances.
	The former integral car garage has been altered and a Utility Room formed.
	There is a timber staircase connecting the ground and first floors.
	Built-in cupboards were looked into but no stored items were moved.
	Kitchen units were visually inspected excluding appliances.
Chimney Breasts and Fireplaces	Not applicable.
Internal Decorations	Internal decorations comprise wallpaper and painted finishes.
	Visually inspected.
Cellars	Not applicable.
Electricity	Mains supply. The electrical installation comprises 13 amp power points whilst the cable where visible is of PVC clad type. The electrical consumer unit is contained within the Utility Room.
	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.
Gas	Mains supply. There is an external gas meter box.
	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure

they work properly and efficiently and meet modern standards.

Water, Plumbing and Bathroom Fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

The ground floor WC and first floor main Bathroom comprise modern replacement units.

There is also a En-Suite Shower Room off the Master Bedroom.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water

Fixed central heating is provided by a modern gas fired `Valliant Ecotec Plus 612` boiler which is within the ground floor WC. This serves water filled radiators throughout. This also provides for domestic hot water which is supplemented by an electric immersion heater and contained within a modern pre-insulated hot water cylinder which is within a cupboard off the first floor Landing.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage

Main sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, Smoke and Burglar Alarms

There appears to be a compliant smoke and heat alarm system within the property, although we would recommend that confirmation be sought in this regard.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

At the date of inspection, the property was furnished whilst the floors were covered.

There was no access gained to any sub-floor areas.

Not all windows were tested during the course of our inspection.


No services were tested during the course of our inspection.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a nondisruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

4. Valuation and Conveyance Issues

Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the conversion of the former integral car garage to form a Utility Room and WC. In addition, a former external door at gable elevation has been in-filled

Estimated Reinstatement Cost for Insurance Purposes

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £310,000 (THREE HUNDRED AND TEN THOUSAND POUNDS STERLING).

Valuation and Market Comments

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £280,000 (TWO HUNDRED AND EIGHTY THOUSAND POUNDS STERLING).

We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. The Surveyor will be entitled not to proceed with the inspection (and will so report promptly to the Seller) if after arriving at the Property, the Surveyor concludes that it is of a type of construction of which the Surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. The Surveyor will also be entitled not to proceed if after arriving at the Property, the Surveyor concludes that the Property is exempt under Part 3 of The Housing (Scotland) Act 2006 as detailed in the (Prescribed Documents) Regulations 2008. DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:





The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 23 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 2.4 tonnes of carbon dioxide every year. You could reduce emissions by switching to renewable energy sources.
